## Discipline Waiver

Lubbock Christian School reserves the right as a private institution to administer corporal punishment; however, we are determined to make every effort to consider some parents' opposition to this method of discipline. If the school feels that a child's behavior warrants corporal punishment and parents do not want LCS to administer punishment, the parents must take the student home for the remainder of the day. This will result in an unexcused absence. If corporal punishment is administered, parents will be notified.

- Administer corporal punishment when necessary.
- Call parent to pick up student from school and student will receive zeros in classes.

## 7<sup>th</sup> - 12<sup>th</sup> Grade Disciplinary Procedures

***7<sup>TH</sup> - 12<sup>TH</sup> grade parents or guardians must agree to these procedure in order to enroll their child at LCS.***

LCS has a commitment to a high standard of student behavior. There are certain unacceptable behaviors that LCS will enforce with a "no tolerance" approach. These specific infractions may result in expulsion from LCS and are listed below.

1. Possession of a weapon (knives included) at school or school functions.
2. Possession of illegal drugs or an arrest for possession of illegal drugs at any time.
3. Alcohol consumption and possession on campus and at school events.
4. An indictment or conviction of any type.

There are other undesirable behaviors which will result in a 1-3 day suspension from school, possible expulsion, and corporal punishment in addition to the suspension. These behaviors include possession of fireworks or igniting fireworks on school campus and at school functions; sexual harassment; blatant disrespect to a teacher, parent-sponsor or guest on campus; and truancy from class or school. Students and parents will not be able to barter for corporal punishment in lieu of suspension.

If a student's dress or hair does not conform to dress code standards, he/she will not be allowed to attend class until the problem has been corrected. The student will be given zeros in classes missed because of dress code infractions.
